1 Introduction

Product Copilot (hereinafter referred to as "Service") is operated by Prio 0 GmbH ("us", "we", or "our"). It can be accessed at https://product-copilot.ai and is an application integrated with Google Chrome browsers, Atlassian Jira/Confluence and Azure DevOps.

Our Privacy Policy governs your visit to https://product-copilot.ai and the Product Copilot browser extension, and explains how we collect, safeguard and disclose information that results from your use of our Service.

We use your data to provide and improve the Service. By using the Service, you agree to the collection and use of information in accordance with this policy. Unless otherwise defined in this Privacy Policy, the terms used in this Privacy Policy have the same meanings as in our Terms and Conditions.

Our Terms and Conditions (Terms) govern all use of our Service and together with the Privacy Policy constitute your agreement with us (Agreement).

2 Definitions

SERVICE means the https://product-copilot.ai website and the Product Copilot browser extension operated by Prio 0 GmbH.

PERSONAL DATA means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

USAGE DATA is data collected automatically either generated by the use of Service or from Service infrastructure itself (for example, the duration of a page visit).

COOKIES are small files stored on your device (computer or mobile device).

DATA CONTROLLER means a natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal data are, or are to be, processed. For the purpose of this Privacy Policy, we are a Data Controller of your data.

DATA PROCESSORS (OR SERVICE PROVIDERS) means any natural or legal person who processes the data on behalf of the Data Controller. We may use the services of various Service Providers in order to process your data more effectively.

DATA SUBJECT is any living individual who is the subject of Personal Data. THE USER is the individual using our Service. The User corresponds to the Data Subject, who is the subject of Personal Data

3 Information Collection and Use

We collect several different types of information for various purposes to provide and improve our Service to you.

4 Types of Data Collected

Personal Data

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you (Personal Data).

Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Cookies and Usage Data
- Data from your Issue Tracker and Wiki systems (Jira, Confluence, Azure DevOps)

We may use your Personal Data to contact you with news on product updates, other information that may be of interest to you, or ask for your feedback.

You may opt out of receiving any, or all, of these communications from us by emailing at info@product-copilot.ai.

Usage Data

We may also collect information that your browser sends whenever you visit our Service or when you access Service by or through a mobile device (Usage Data).

This Usage Data may include information such as

- your computer's Internet Protocol address (e.g. IP address)
- browser type, browser version
- the pages of our Service that you visit
- the time and date of your visit

- the time spent on those pages
- · unique device identifiers and other diagnostic data

When you access Service with a mobile device, this Usage Data may include information such as

- the type of mobile device you use
- your mobile device unique ID
- the IP address of your mobile device
- your mobile operating system
- the type of mobile Internet browser you use
- unique device identifiers and other diagnostic data.

Tracking Cookies Data

We use cookies and similar tracking technologies to track the activity on our Service and we hold certain information.

Cookies are files with a small amount of data which may include an anonymous unique identifier. Cookies are sent to your browser from a website and stored on your device. Other tracking technologies may also be used such as beacons, tags and scripts to collect and track information and to improve and analyze our Service.

You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent.

However, if you do not accept cookies, you may not be able to use some portions of our Service.

Examples of Cookies we use:

- Session Cookies: We use Session Cookies to operate our Service.
- Preference Cookies: We use Preference Cookies to remember your preferences and various settings.
- Security Cookies: We use Security Cookies for security purposes.

5 Use of Data

Product Copilot uses the collected data for various purposes:

- to provide and maintain our Service
- to notify you about changes to our Service
- to allow you to participate in interactive features of our Service when you choose to do so

- to provide customer support
- · to gather analysis or valuable information so that we can improve our Service
- to monitor the usage of our Service
- to detect, prevent and address technical issues
- to fulfill any other purpose for which you provide it
- to carry out our obligations and enforce our rights arising from any contracts entered into between you and us
- to provide you with notices about your account and/or subscription, including expiration and renewal notices, email-instructions, etc.
- to provide you with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about unless you have opted not to receive such information
- in any other way we may describe when you provide the information
- for any other purpose with your consent.

In particular, to provide and maintain our Service, Product Copilot uses your Jira/Confluence/Azure DevOps data as described here:

- The Service stores the access tokens that you enter when setting up Product Copilot
- The Service reads your issues and wiki pages and associated data (date, time, summary, description, comments, participants, status) to provide better answers in Al chats.
- The Service subscribes to push notifications from Jira/Confluence/Azure DevOps to detect changes to your issues and wiki pages and associated data to update the information for these items.

We do persist your chat history in order to provide you with access to previous chats.

The service stores any feedback you provide when using the app.

When you unsubscribe from Product Copilot all access tokens and push notifications are deleted.

Your email address will be used to provide notices and relevant information.

6 Retention of Data

We will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy.

We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

We will also retain Usage Data for internal analysis purposes.

Usage Data is generally retained for a shorter period, except when this data is used to strengthen the security or to improve the functionality of our Service, or we are legally obligated to retain this data for longer time periods.

7 Transfer of Data

Your information, including Personal Data, may be transferred to - and maintained on - computers located outside of your state, province, country or other governmental jurisdiction where the data protection laws may differ from those of your jurisdiction.

If you are located outside of Germany and choose to provide information to us, please note that we transfer the data, including Personal Data, to Germany and process it there.

Your consent to this Privacy Policy followed by your submission of such information represents your agreement to that transfer.

Prio 0 GmbH will take all the steps reasonably necessary to ensure that your data is treated securely and in accordance with this Privacy Policy and no transfer of your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of your data and other personal information.

8 Disclosure of Data

We may disclose personal information that we collect, or you provide:

- Disclosure for Law Enforcement. Under certain circumstances, we may be required to disclose your Personal Data if required to do so by law or in response to valid requests by public authorities.
- Business Transaction. If we or our subsidiaries are involved in a merger, acquisition or asset sale, your Personal Data may be transferred.
- Other cases. We may disclose your information also: i. to our subsidiaries and affiliates; i. to contractors, service providers, and other third parties we use to support our business.

9 Security of Data

The security of your data is important to us but remember that no method of transmission over the Internet or method of electronic storage is 100% secure.

While we strive to use commercially acceptable means to protect your Personal Data, we cannot guarantee its absolute security.

10 Your Data Protection Rights Under General Data Protection Regulation (GDPR)
